## The Economics of Happiness—creating a more equitable world

A partner event hosted jointly by Local Futures, Global Hub and Initiatives of Change

What if human well-being didn't have to be at the expense of the environment? What if we could simultaneously increase genuine prosperity, reduce social inequality, and tackle climate change? With some simple economic shifts, all this becomes possible. That's because so many of our current crises—financial, social and ecological—are linked to the scale of the economy. Localisation is a solution-multiplier that systemically reduces economic scale, creating benefits that ripple throughout society. In this day-long seminar, Helena Norberg-Hodge will share an alternative paradigm she calls the 'economics of happiness'. Her talk will highlight human-scale economies and the steps—at the community, national, and international levels—that can bring us there. She will be joined by Lawrence Bloom, a former chairman at UNEP and at the World Economic Forum, and Diego Isabel La Moneda, founder of Global Hub for the Common Good. Helena's film *The Economics of Happiness* will also be screened and, in discussion with the audience, the speakers will explore how we can sustainably meet both human and ecological needs by going local.

**Helena Norberg-Hodge** is a pioneer of the new economy movement and recipient of the Right Livelihood Award and the Goi Peace Prize. Her inspirational book *Ancient Futures* has been translated into more than 35 languages. She is co-author of *Bringing the Food Economy Home*



and *From the Ground Up: Rethinking Industrial Agriculture* and the producer of the award-winning documentary *The Economics of Happiness*. She is also the director of Local Futures (formerly ISEC) and the International Alliance for Localization (IAL), and a founding member of the International Forum on Globalisation (IFG) and The Global Ecovillage Network.

# THE ECONOMICS OF HAPPINESS

Since leaving Ericsson in 2002, **Stephen Hinton** has developed ways for organizations and communities to take the lead in sustainable development. Addressing resource shortages as limits to growth, he went on to work with envisioning techniques to develop ideas for sustainability; and then to practical implementation of a range of instruments, from city walking maps to flexible pollutant fees. Stephen was one of the founders of the Transition movement in Sweden, and the co-founder of the Swedish Eco-village, Änggärdet. He is often engaged to speak on topics such as moving away from an industrial mindset, transitioning away from fossil fuels, co-creation and new financial possibilities as well as the inner transition accompanying the move from consuming to co-producing.
